5	The Company had allotted 366559623 equity shares of Rs. 1/- each, at a price of Rs. 1.20/- per share (including premium of Rs. 0.20/- per equity share) on 25th November, 2024 on Rights basis pursuant to letter of offer dated 4th September, 2024. Thereafter, on Novemver 28, 2024 and December 02, 2024, BSE Limited have accorded listing and trading approval respectivly, for commencement of trading effective from December 02, 2024. The expenses related to the Rights Issue amounting of Rs. 88.55 Lacs have been classified as exceptional items and have separetly shown in these financial results.

1. We have reviewed the accompanying statement of unaudited financial results of **ARC Finance Limited** ('the Company') for the quarter and nine months ended December 31, 2024 (the "Statement") being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements') Regulations, 2015.
